  - i. Roll call vote: Tamara Stern: 5; Heidi Chan-Sarantopoulos: 3; Stephen Stowe: 2
  - ii. No candidate has been elected (6 votes, or quorum, is needed)

### IV. Report of Council First Vice President (00:28:30)

- **a.** Dina Guirguis asked Second Vice President Robert Aguilar to summarize the Chancellor's meeting on October 3<sup>rd</sup>
  - i. Tracking children's attendance (00:29:00)- There is no data on demographics yet, appropriate agencies are visiting homes
  - ii. Cleaning of busses (00:30:24)- Using an electrostatic cleaning system
  - iii. Randomized testing (00:30:37)- obligated if student is called, using a saliva test and a new test with samples taken from lower nostril
  - iv. Curriculum (00:31:48)- schools choose curriculum, Principals have full autonomy
  - v. iPads (00:32:18)- student forced to return iPad, concern over procedure
  - vi. D75 students (00:32:40)- not exempt from randomized testing

- vii. Going forward (00:32:50)- will eventually have real time monitoring of Covid-19 cases through an app, randomized testing will be confidential, but reported to CDC for tracking
- viii. Mayoral control (00:33:50)- did not disagree that mayoral issues are not the problem is with the current mayor
- ix. Adele Doyle sent a letter to Dr. O'Brien regarding the random Covid-19 testing and her concerns (00:34:43)
  - 1. The letter will be posted on the CEC website along with the minutes
  - 2. Adele attended the Deputy Chancellor's meeting where she felt parents' questions were not answered and information provided was not clear (00:39:05)
- x. Inga Smolyar discussed the closing of the school that did not have any Covid-19 cases, but is in the governor's yellow zone (00:46:40)

## V. Report of Community Interim Acting Superintendent (00:51:15)

- **a.** Dr. O'Brien answered questions submitted during the week and responded to comments from the council members
  - i. District Enrollment (00:51:57)- 35,500 students currently enrolled compared to 36,600 last year
  - ii. School closures (00:52:25)- 18 out of 41 schools are closed, 5 out of 11 Pre-K centers are closed
  - iii. School attendance (00:52:46)- 94% attendance rate for fully remote students, 93% attendance rate for hybrid-in class students, 92% attendance rate for hybrid-remote students
  - iv. Devices (00:53:03)- more than 1,200 internet ready iPads have been requested but not received, approximately 500 laptops in schools without Wifi capabilities
  - v. Ways to move the district further (00:53:52)- Equity team, adding D75 seats, launching of Restorative Justice program for stand-alone middle schools
  - vi. Questions from council members
    - 1. Alice Licato asked about how discipline would be handled in light of the Restorative Justice Program (00:56:25)
    - 2. Adele Doyle asked about identifying what the students are learning as part of their curriculum (00:58:00)
    - 3. Simeon Stolzberg asked about a response for parents who are concerned about live instruction during remote learning (01:02:48)
    - 4. Dina Guirguis asked what needs to happen to reopen schools that have been closed with no positive cases of Covid-19 (01:03:50)
    - 5. Simeon Stolzberg asked about the district collecting information to see how much students have fallen behind and how many would need remedial classes (01:04:53)
    - 6. Alan Aja asked how will the equity committee fight for a more inclusive and culturally relevant curriculum (01:07:40)
