- a. Approval of September Business Meeting Minutes
 - i. Minutes unanimously approved

III. **New Business**

- a. President Steve Stowe discussed the presentation that the Office of District Planning was supposed to give at the Calendar Meeting
 - i. Planning is a major role of CECs—they influence the type of school being built
 - ii. The District 20 map is color coded to indicate the capacity of the schools
 - 1. Red schools are severely overcrowded (150% capacity and above)
 - 2. Orange schools very overcrowded (125% 150% capacity)
 - 3. Yellow schools are above 100% Capacity (100% 125% capacity)
 - 4. Green schools are below capacity (approximately 75-100% capacity)
 - iii. Comments from the council
 - 1. Kevin Zhao asked for clarification about the percentages represented by the color coding of the map, and if we have the numerical data of capacity and students actually enrolled
 - 2. Maya Rozenblat asked if there is a model demonstrating how the ODP predicts future enrollment, commented that raising rent costs in Manhattan will lead to people moving back to Brooklyn and an increase in school enrollment, asked that she be notified if there is any news about bilingual programs
 - 3. Vito LaBella asked if the Santander property (located on 5th Avenue, between 88th and 89th Streets) was purchased or still in the process of being purchased

- iv. Elementary school enrollment has decreased as students attended schools in other districts
- v. Middle school capacity increased with the opening of the new school on 86th Street
 - 1. If enrollment does not increase, the only school needed will be the middle school at the Nathans site
- **vi.** There is an adequate number of D75 seats in elementary schools, but not in middle or high schools
 - 1. There was talk about the former Angel Guardian Home (Located at 12th Avenue, Between 63rd and 64th Streets) including D75 seats once the school is built
- **vii.** There are three types of specialty programs in D20: ASD programs, G&T programs, and Bilingual Education programs
- **b.** Approval of the minutes from the October Special Meetings

 - ii. Remote Learning Discussion: Minutes unanimously approved
