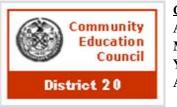

- **a.** Steve Gonzales and Gayle Mandaro gave a presentation on the proposed acquisition of a new site on Fifth Avenue between 88th and 89th Streets for a new 572 seat primary school

- c. Feedback from council members (01:14:22)
 - i. Steve Stowe asked about the practicality of building another elementary school when there are two in close proximity; Does the size of the lot preclude it from being a middle school or high school (01:15:54); inquired about the auditorium upgrade for j.H.S. 201 (01:23:57)
 - ii. Alice Licato stated that there is a need for a high school and having a screened high school in D20 is something that has been discussed in the past (01:17:17); for clarification, asked if this presentation marks the opening of the 45 day public comment period (01:21:39); asked If the cost of the property is public knowledge- not until the sale is finalized (01:28:57)
 - iii. Adele Doyle reiterated the need for a high school and how it seems that consideration from the community has been excluded (01:18:43); why no one seems to want to build a high school (01:19:45)
 - iv. Vito LaBella asked if lots 28 and 39 are owned by the same person and if the sale has already gone through (01:25:08); the price per square foot (01:26:34)

Robert Aguilar stated that he feels the opening amendment is on point, but the resolution seems to lose focus after that, it feels more like a resolution supporting G&T rather than an anti-Asian hate resolution, bothered by the fact that it was just presented and there is no time to make the changes necessary to make it powerful (03:09:23)
- **g.** Steve Stowe made a motion to begin public speaking; Second- Inga Smolyar, but there are council members who would like to comment (03:11:39)
- h. Vito LaBella stated that there are a lot of conflating issues, and he believes that the Asian community feels that they are being attacked from both sides: individuals who don't support what they believe in and those who are conflating anti-Asian and anti-China (03:11:51)
- i. Alice Licato clarified Mr. LaBella's statement that people may have an issue with the Chinese government's policies, but not the Chinese people; emphasized that voting on the resolution without going over each whereas statement puts the council in a difficult position (03:14:11)

 - i. Sandy Chum-Wu stated that she feels the resolution does not reflect her concerns and challenges as part of the Asian community, a diversity and inclusion professional, as well as the PS 682 PTO President; it does not identify the challenges, systemic injustices, or the obstacles that the community experiences, would like to see how the Asian community was polled (03:17:19)

Francine Almash agreed that the resolution feels like an attempt to push G&T; confused that in the context of the past year, the council has tried to speak out against anti-black violence but was denied for it not being an educational issue; hopes that the council fixes the resolution so it does what it is intended to do; asked why it is ok for the council to address anti-Asian violence but not anti-black violence (03:21:53)
