
- a. Parents Survey

 - 1. Has to be moved to a separate line by the March 25th deadline (00:25:30)

- i. Simeon Stolzberg led a discussion prior to writing a resolution about the summer and next school year

- ii. For the Summer (00:28:25)
 - 1. Are they offering programs for the summer?
 - 2. Making all the DOE computer programs accessible to parents (00:28:51)
- iii. For the Fall (00:29:24)
 - 1. With teachers eligible for vaccination, there is potential for schools to open 5 days per week
 - 2. What does that mean for remote learning?
 - 3. How will the schools build up trust?
