III. New Business

- I. Public Speaking Session (General)
 - No participants signed up nor did any participant volunteer (virtually and in-person)
- II. Conversation between CEC 20 and Assemblyman Lester Chang
 - CEC 20 and Assemblyman Lester Chang spoke on current issues impacting District 20 including the Class Size Law,influx of migrant students, shortage of teachers and teacher hiring, the status of the School Construction Authority,

III. Report from Deputy Superintendent Joseph O'Brian

- The new interim acting principal for M.S. 936, Raquel Diaz introduced herself to the community and spoke on her commitments as the new acting principal.
- Deputy Superintendent Joseph O'Brian gave a report that included a review of the 2022 2023 District Priorities, district goals for the 2023 2024 school year, and an overview of the Respect for All Initiative.
- Review of 2022 2023 District Priorities: Throughout the past school year Superintendent Pretto and his office prioritized community engagement by conducting listening tours, presenting at multiple CEC meetings, PTA visit meetings, and attended/presented at monthly presidents council meetings. In regards to District Planning and Development, established a rezoning committee to aid in zoning lines for the three new schools opening in Fall 2024, designed and expanded districtwide academically screened middle school opportunities, designed and enhanced district wide elementary gifted and talented program, expansion of dual language programs in elementary and middle school, expansion of D20 STEAM Initiative programs, and launch of Civics for All District Partnership. Integrated social-emotional learning. Reduce chronic absenteeism.
- District Goals for 2023 2024 School Year: Mirror Chancellor Banks priorities, all students learn to read well, are physically and emotionally safe, have high-quality academic experience, graduate college and career ready to have

economic security, all districts and schools are more inclusive and responsive to parents and families, and to reduce chronic absenteeism.

- Overview of Respect for All Initiative: All students deserve a safe, supportive school environment free of discrimination, harassment, intimidation and/or bullying, including sexual harassment. Went over the Chancellor's regulations, means to contact, rights when reporting incidents, and confidentiality.
- Deputy O'Brian gave insight into what to expect for the September report which will include SY 2022 2023 EOY District Data, NYS Assessements, IReady Reading and Math Grades, Acadience, and examining D20 Bullying and Suicide Ideation.
